GCIS SUS Committee Meeting Minutes

Review of Previous Year Activities

1. Mike Nazareth:

- We revamped GCiS, collecting data via a new student opt-in form. We also revamped online portal for users.
- Last year, 6000 students completed the form. That's 7% of number that were in the automatic system the previous year (88K). Thinks we can double or triple that with improved outreach to students and by opening up the student form earlier and perhaps also for a longer period of time.

2. Blair Monroe:

- There are three pieces: Mike's site holds background info, etc. CIMES site includes the actual student sign up form and the administrative side where users pull down data submitted by students.
- Went well last year; very few complaints/requests for help on part of students.
- One thing we may address is that some students had difficulty locating desired program of study in the dropdown, so may add a search feature there.

3. Rebecca Augustyniak

All activities in CIMES/GCIS scope of work were completed. Universities invoiced in December.
 Those institutions that have not yet paid may want to make sure the right person at their institution received the invoice. Rebecca will post the wrap up so they can check.

4. Others:

- Steve Pritz): Asked if it was possible to tell if the yield was better with the more targeted recipient list. Mike N. said he couldn't say, but doubted that was the case at UF.
- Devon Jensen: It's still better to target students we know are actively interested; improved marketing/outreach will improve the numbers.
- Megan Kuehner: Did program directors complain about lower numbers? (Unknown)
- Sabrina Capps: At UWF, only she and another admin could access the data. How did others get program chairs to send the info out? (Steve Pritz: UF let anyone that asked for access have it.)

Plans for New Cycle

5. Mike Nazareth:

- Timeline: We opened the student form late last year. This year, we'd hoped to open it April 1; didn't make that, but it is open now.
- Do we want to close it July 31 as we did last year or close it later? Mike suggests essentially not closing it at all (other than a couple of weeks to purge data in the spring).

6. Discussion:

- Brian Barton: Undergrads are gone in the summer, so definitely needs to be later than July 31.
- Mike N.: If we did leave it open, we'd need to remind students to update their info as their interests change, etc.
- Amy Finley: How would we handle purging data if we left it open? When a student enters data, they may think it's there "forever." But we need to be able to clean the data.
- Blair M.: Keeping form open may result in more students completing a second form because they
 forget they already did it or because their interests have changed.
- Mike N.: Can we make it so when a student returns, they can update their record but not create a new one.
- Blair M.: We may be able to base it on email address or other consistent info, but not sure. It's one thing to stop duplicates but another to also allow them to update.
- Mike N.: Last year, each institution was supposed to include an unsubscribe link with their communications.
- Mike N.: Desire is to keep form open except for purge time, stop duplicate records, allow updating. If individual schools are not ready now, they can wait to market it, but form is open.

Demonstration of New Features

7. Blair Monroe demonstrated the user search form, ability to filter by institution and program, ability to download spreadsheet limited to your search criteria.


8. Discussion:

- Mike N.: Asked about the ability to download all records at once without using the search form.
- Amy F.: Can we add ability to search for only records added after a certain date (so you only get new records you haven't already downloaded)?
- Blair M: We will add that feature now, but wait to make other changes to the form until everyone
 uses it this year and we have concrete feedback on needs. Student form is live now. Admin
 changes may take about a week to put in place.

- Blair M.: Committee members are super users that have ability to create/delete accounts for other users at their institution. Will set up option to delegate that right to another user.
- Blair M: There's also a new snapshot feature where one can view many system analytics and download even more.
- Blair M: The new admin area is set up to force every user annually to agree to the GCIS terms of
 use regarding the data collected. If they don't, after a certain time, their account will be deleted.
- Mike N: FYI, last year's student info has been purged from GCIS. Likewise, institutions need to purge
 any stored data. Can hang on to data for non-grads that applied for a program or took other
 action to show continued interest. Student that filled out form as a junior will need to fill out a new
 one as a senior.

Strengthening Student Outreach/Recruitment

- 9. What worked? Highest response rates were UNF and FL Poly.
 - Megan K.: UNF cast a wide net, worked closely with registrar. Next year may promote it in Canvas.
 - Andrew Konapelsky: FL Poly sent email to all seniors. Almost promoted via some capstone courses (for seniors).
 - Albert Hoyt: FIU hopes to reach out to central advising group to help this year.
 - Rebecca A.: Shared flyer CIMES created, available for use by any institution that wishes.



April 1, 2022, Florida students begin registering in GCIS and Florida University

May 18, 2022, Florida Universities access GCIS Database and student data to recruit students for Graduate School

March 17, 2023, Deadline for students to register for GCIS (most students register from May to October 2022 for Fall 2023 Graduate School consideration)

Actions Items

- Purge all old GCIS data from your institutional records for students that have graduated by Spring 2022 or requested to Unsubscribed from your recruiting efforts. Students who graduate Fall 2022 onward can remain as viable candidates in your recruiting systems.
- GCIS is live until March 17, 2023. Each SUS institution determines when to market to their undergraduates keeping in mind that graduate recruiting begins by September 2022 for Fall 2023 consideration (2 potential marketing templates are attached).
- Each SUS institution is to manage their own Users/Access. CIMES has created an interface for institutions to delete, add, edit your own users (contact Blair for instructions).
- Some institutions have not paid for GCIS in 2021-2022. See attached report and contact Rebecca @ CIMES.
- ~\$750 is due per institution for GCIS in 2022-2023 for ongoing maintenance after receipt of the invoice and no later than 9/1/2022




