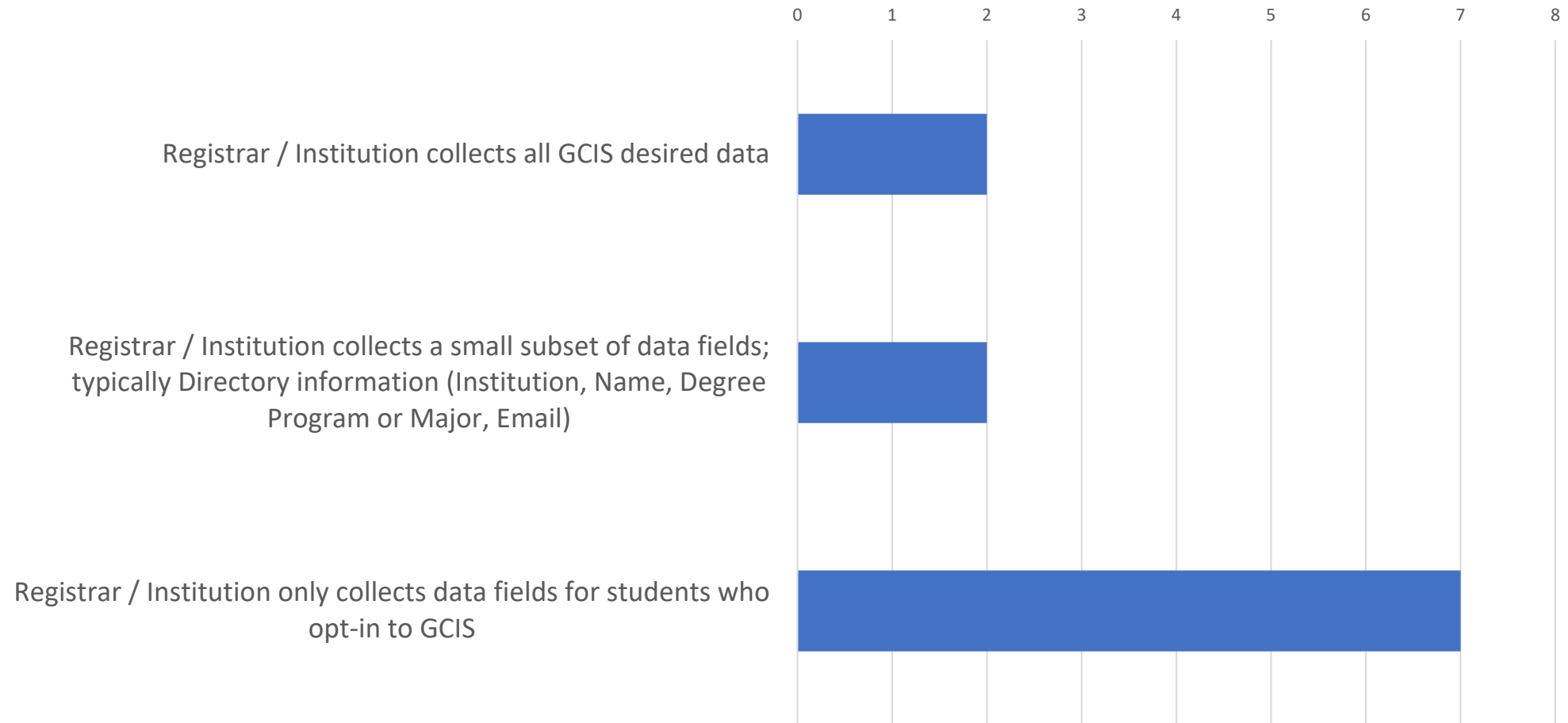

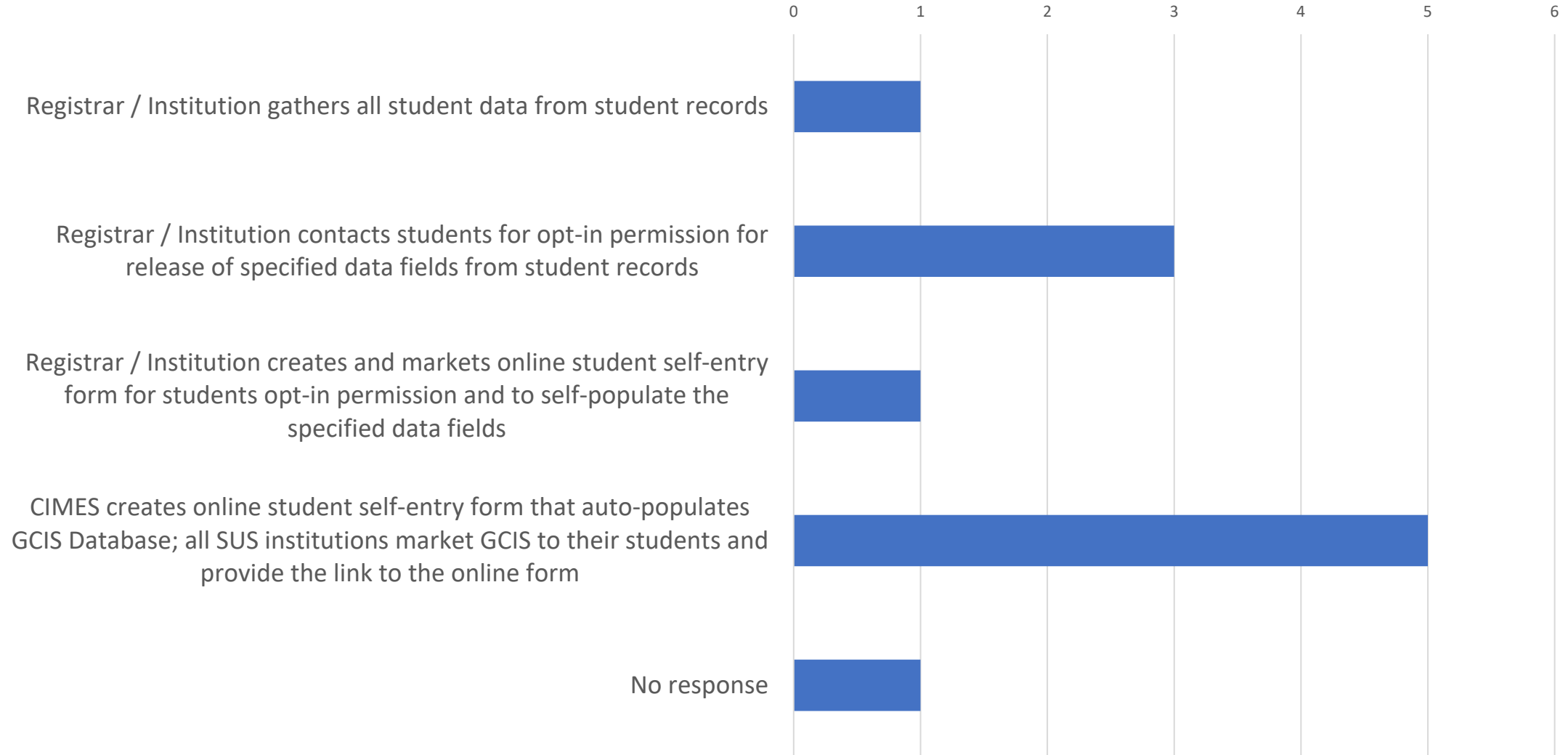

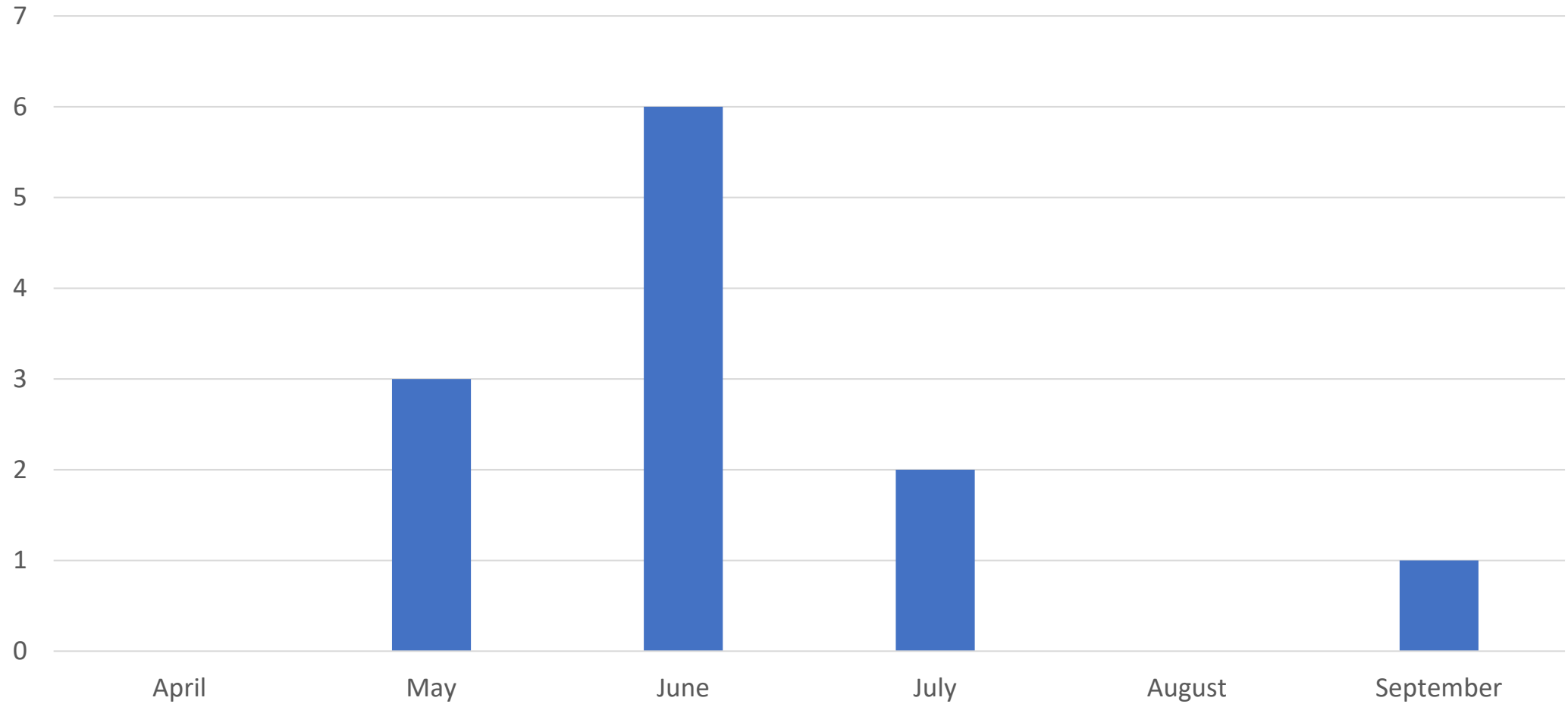
Your preference for student data collection



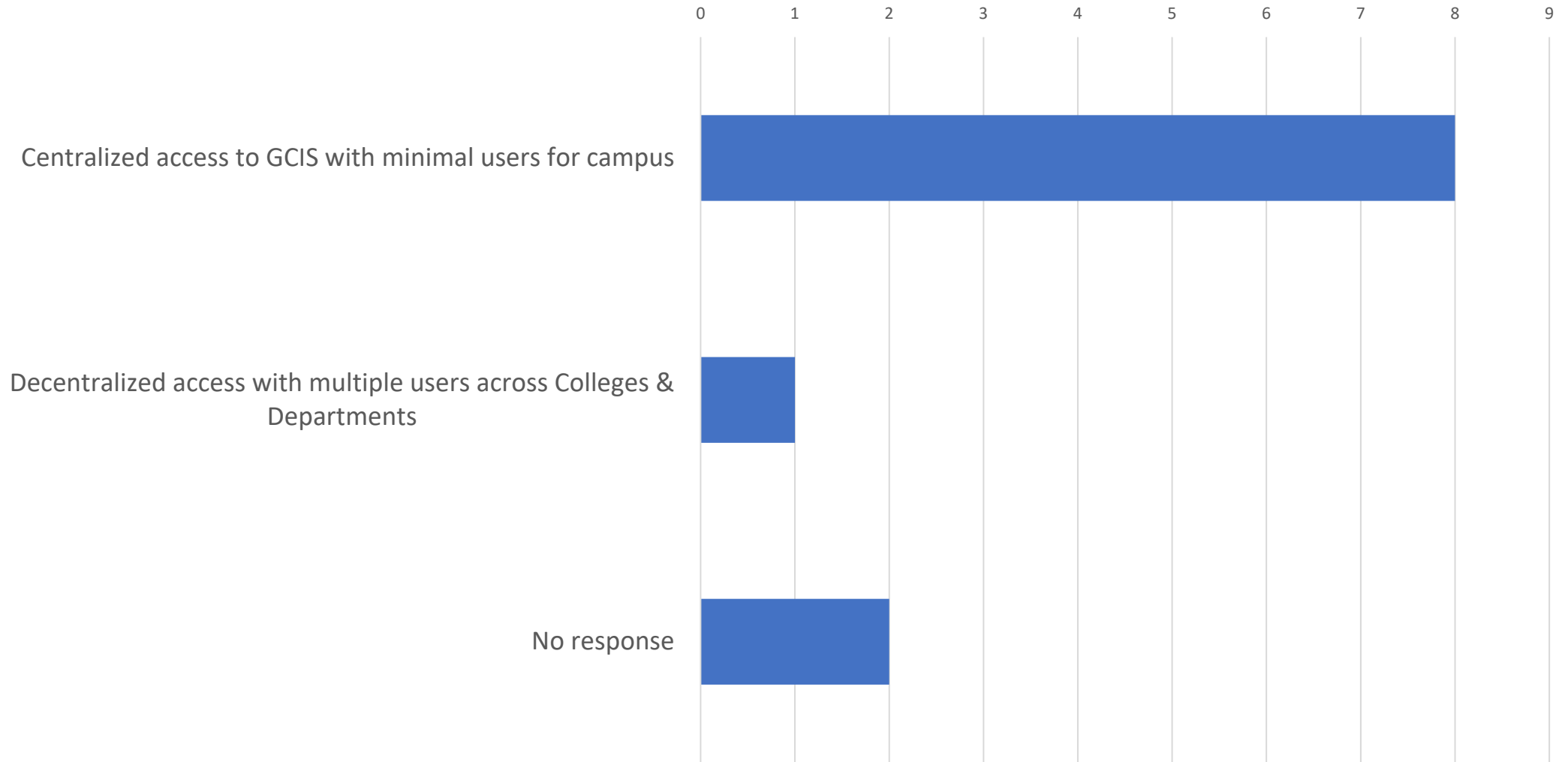
Your preference for the source of student data for GCIS



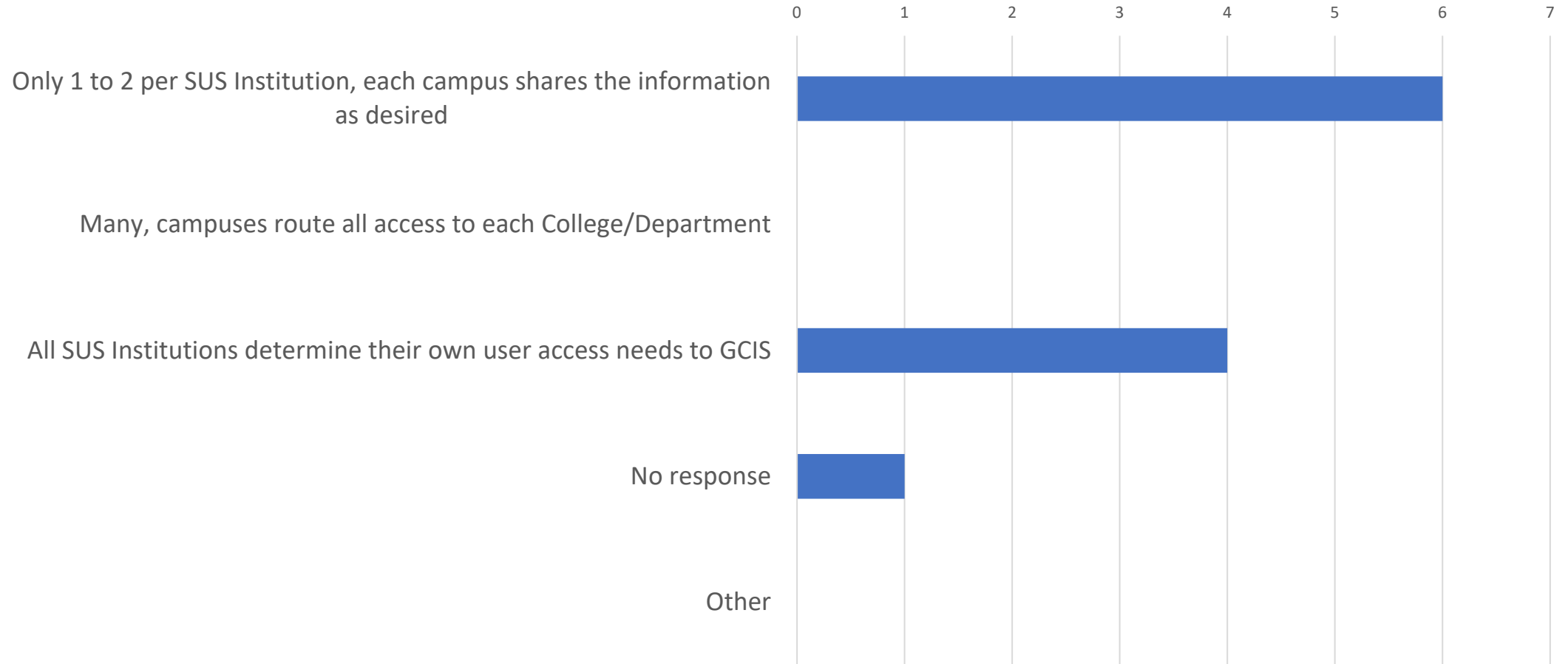
Preferred month to upload your student data with final spring grades and including those not graduating



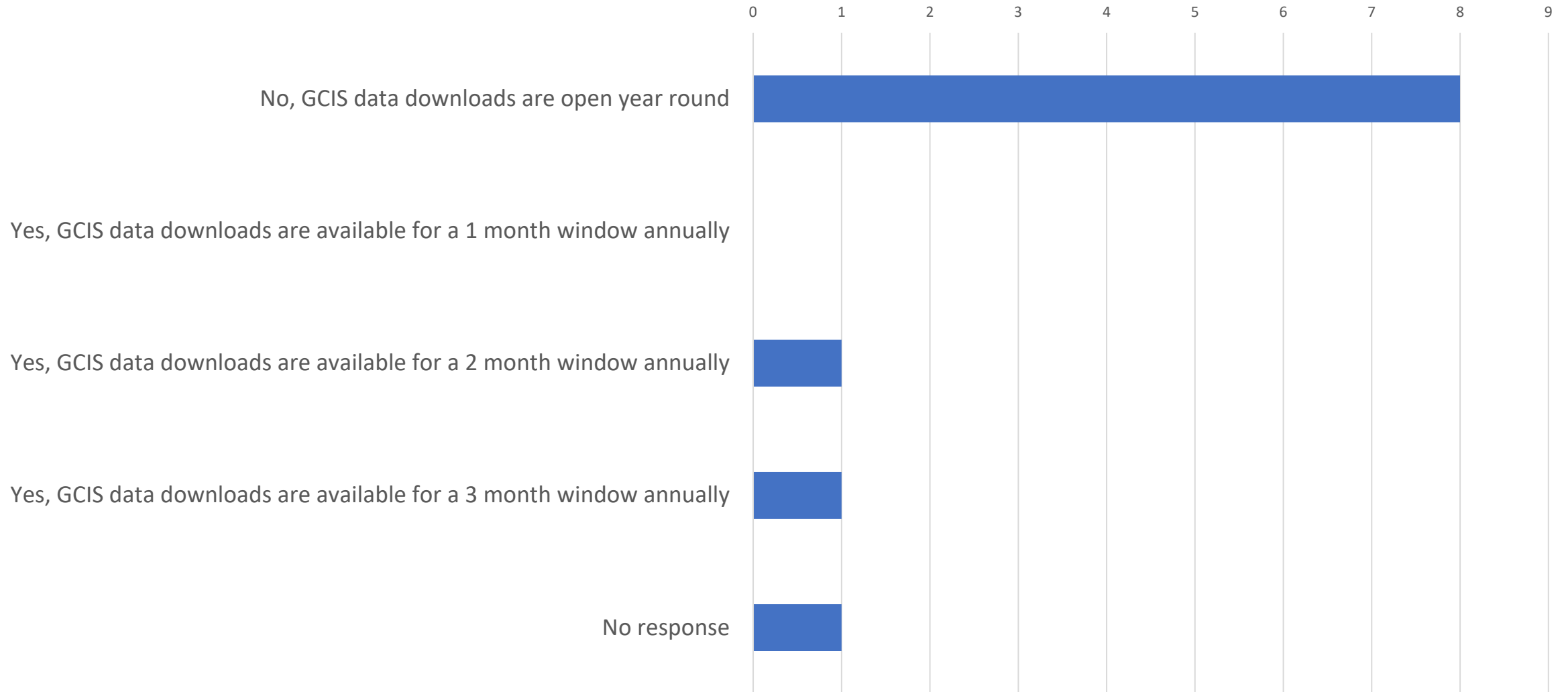

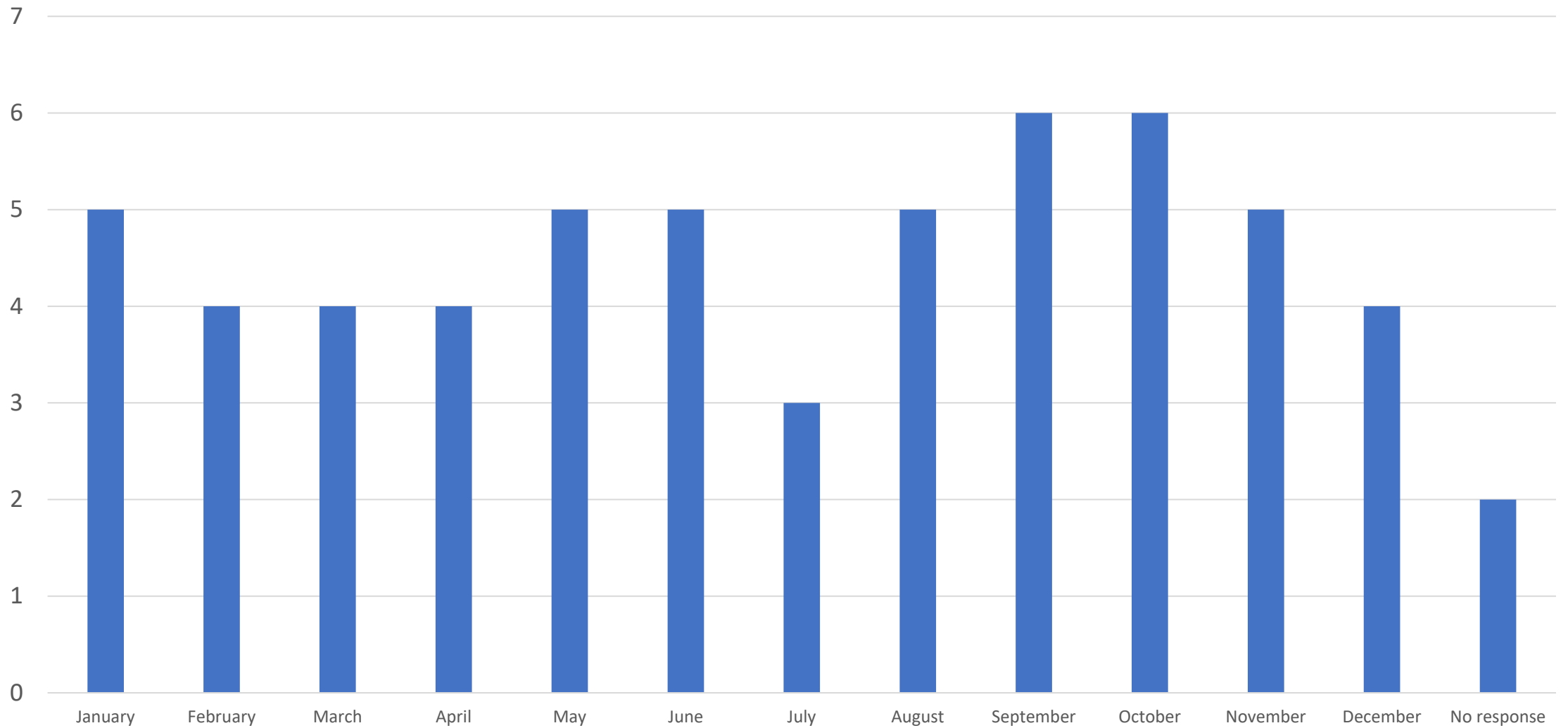
How many Users would you prefer to have access to the GCIS database?



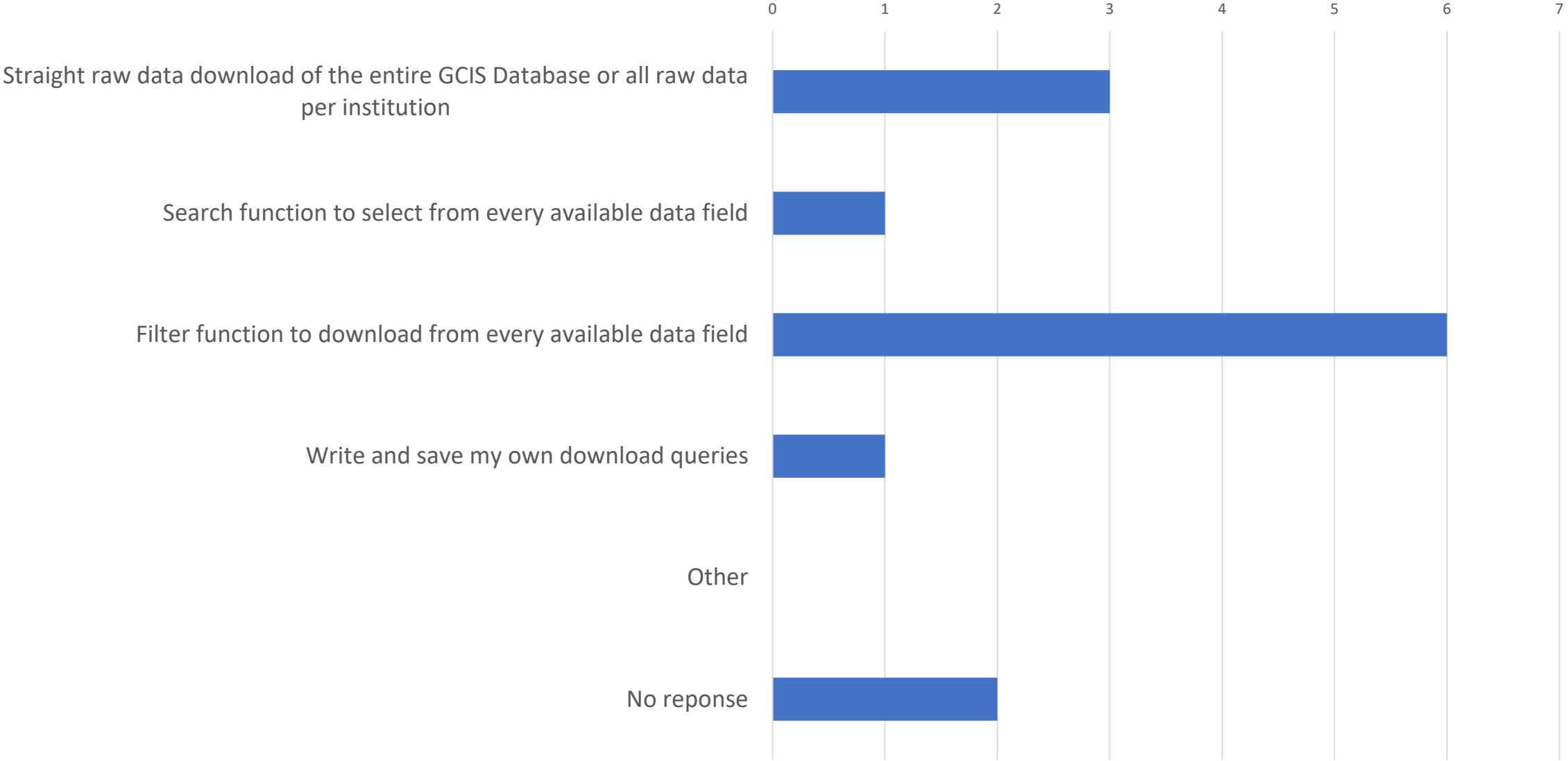
Should there be a limitation on when Users can download GCIS data annually?



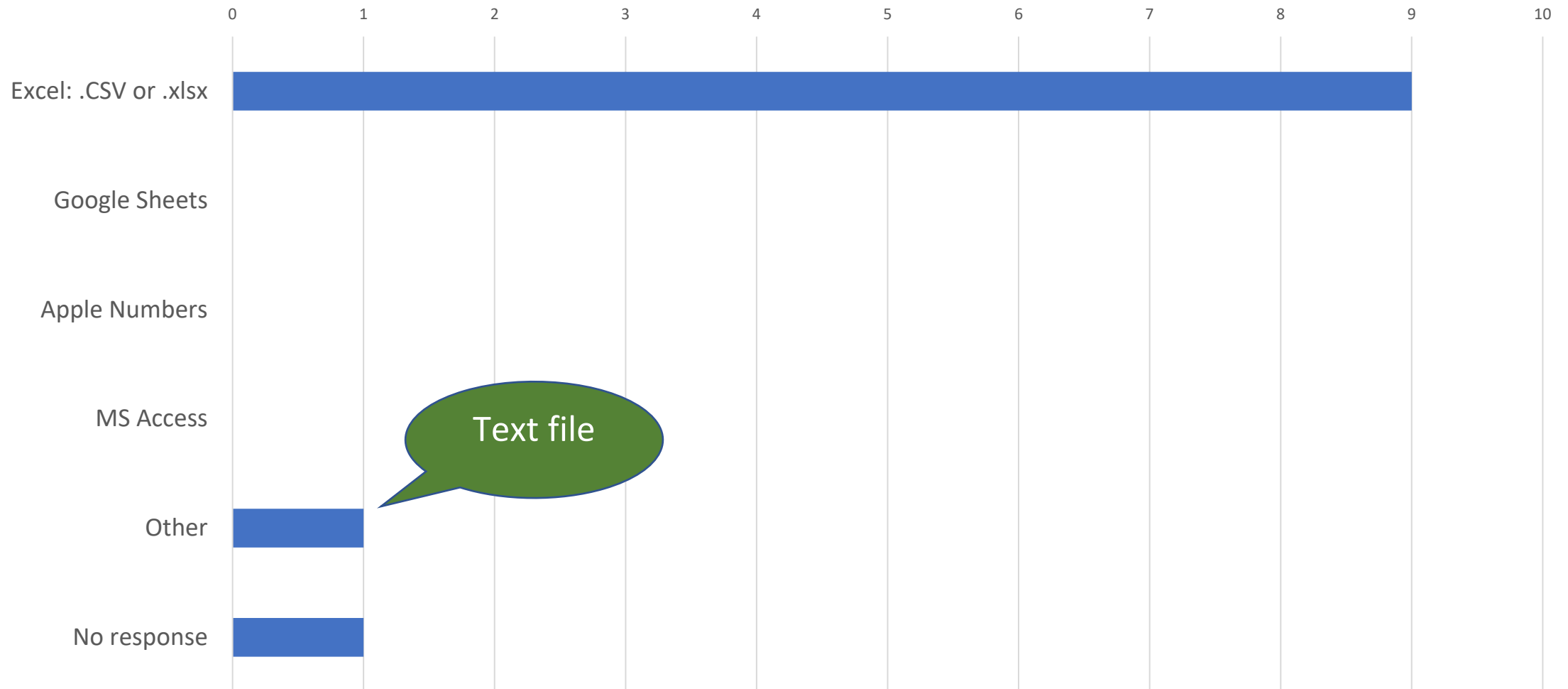
What are the ideal months to download GCIS data? Please check all that apply.



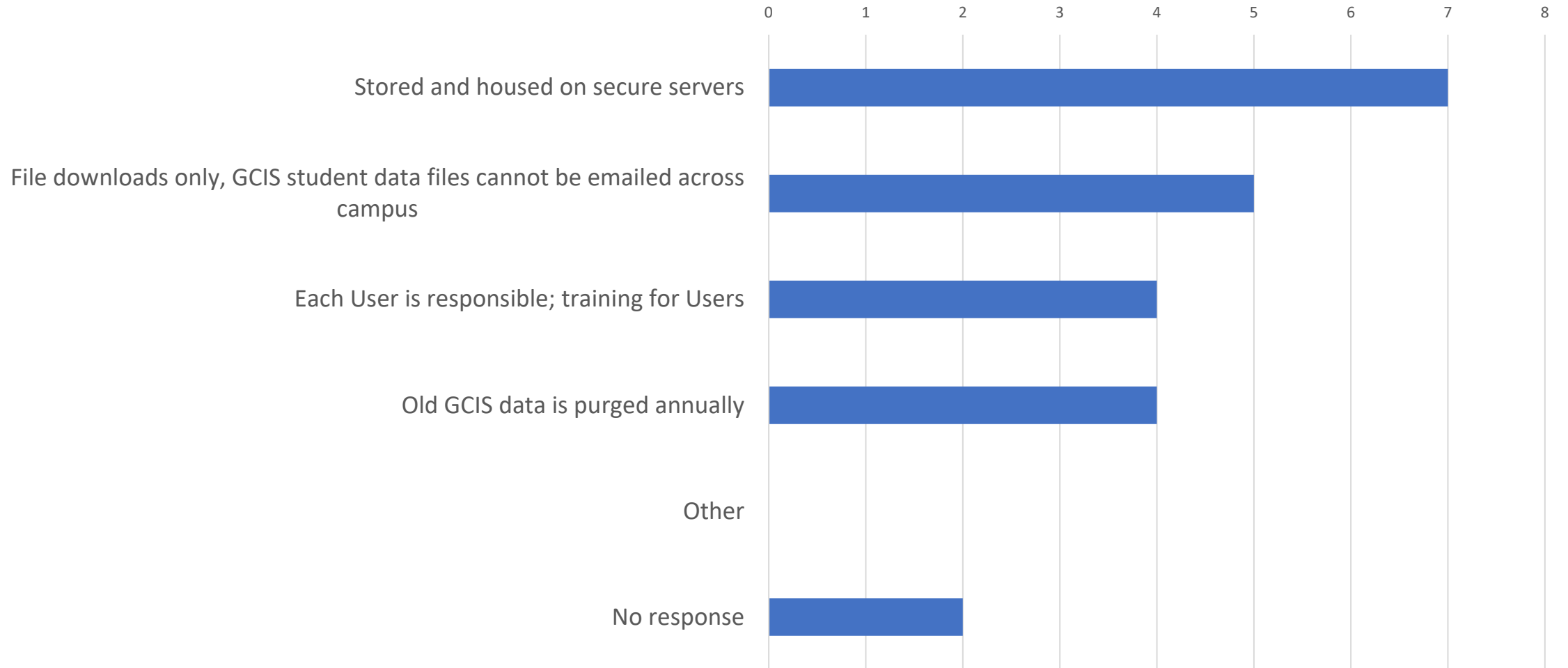
When downloading from GCIS, what aspects are important?



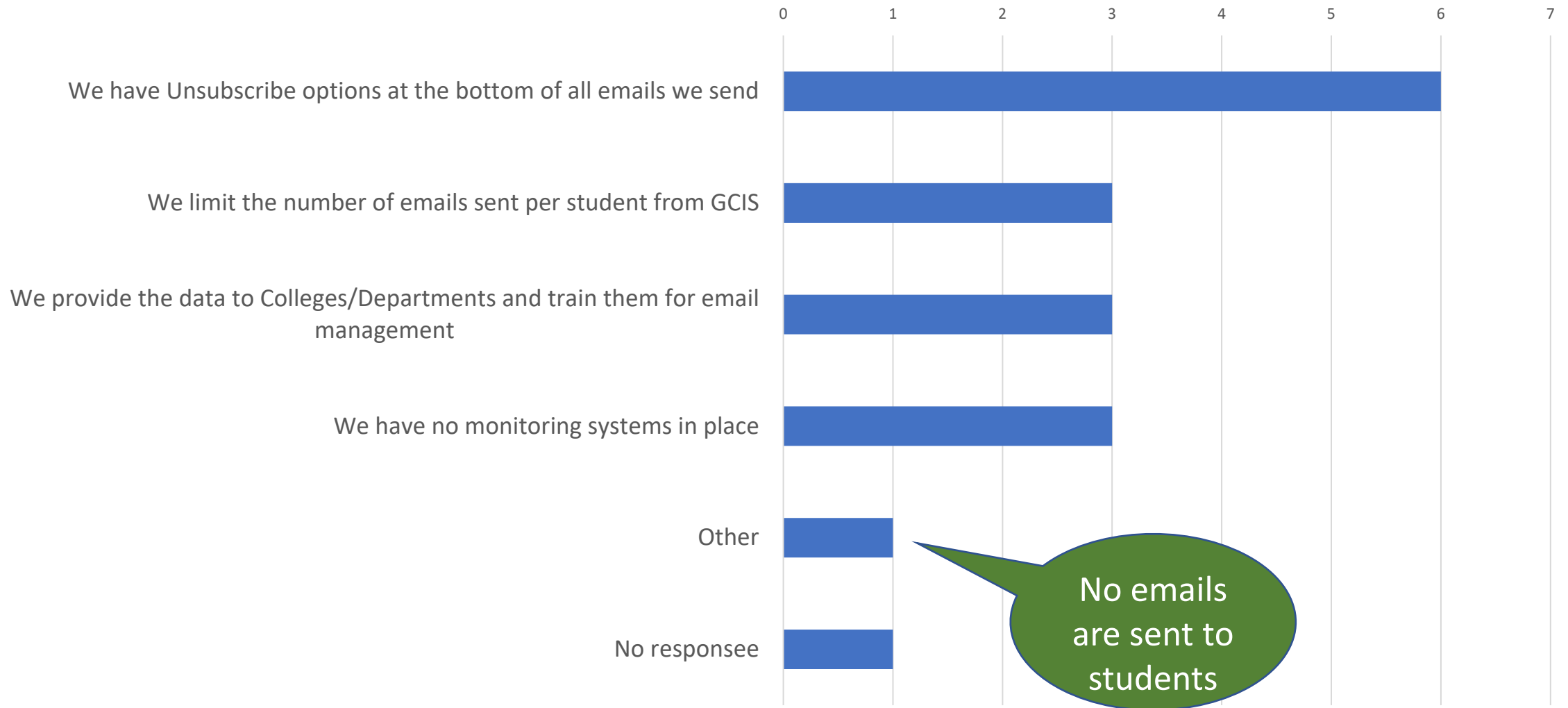
What is your preferred format or document type downloading from the GCIS database?
